



QwikLine Industrial Products Limited Lifetime Warranty

All tools and parts branded with the QwikLine Industrial Products (“QwikLine”) name is warranted against defects in materials and workmanship. QwikLine, or one of its authorized representatives, will, at QwikLine’s option, repair, replace or recondition the product without charge, or refund the purchase price of the product, if the defective or malfunctioning tool or part is returned to QwikLine or one of its authorized representatives. This shall constitute the exclusive remedy for breach of warranty. This warranty shall be invalidated by any abuse, misuse, misapplication or improper installation of the product, vandalism, negligence, damage from adverse water conditions or chemicals, or any other circumstances causing damage to the product. Please be sure to include your name and address with the tool or part, and describe the nature of the problem. Specifically excluded from the QwikLine Limited Lifetime Warranty are components within the QwikLine products that are reasonably expected to be used up, become damaged, or wear during use. This includes, but is not limited to, parts such as the cutting mechanism within the QwikLine Thread Chaser, as well as Drive Sockets, and Product Cases.

The QwikLine Thread Chaser is designed to save time and avoid major disassembly where the threads in non-structural or non-load bearing portions of the fastener have been damaged. Please be sure to replace all threaded rods and bolts where the integrity of the rods or bolts may be compromised either prior to, or as a result of, using the QwikLine Thread Chaser, particularly in applications affecting performance or safety. QwikLine disclaims any warranty or liability resulting from the use of damaged fasteners reconditioned by the QwikLine Thread Chaser or the continued use of any fastener where the integrity of the fastener has been compromised rendering the fastener unfit for reconditioning or continued use. Please follow the recommended guidelines from the fastener manufacturer regarding replacement of damaged fasteners.

QwikLine shall have no obligation pursuant to the QwikLine Limited Lifetime Warranty with respect to any tools or parts which in QwikLine's sole judgement have been altered, damaged, misused, abused, badly worn, lost or improperly maintained. This Warranty is null and void if the customer, or any other person other than an authorized representative of QwikLine, has made any attempt to service or modify the tool prior to its return to QwikLine under this Warranty.

QwikLine reserves the right to make periodic changes in construction or tool design at any time. QwikLine specifically reserves the right to make these changes without incurring any obligation or incorporating such changes or updates in tools or parts previously distributed.
